## **Executive Summary**

SB 1189, introduced by Senator Limón during the 2023-2024 Regular Session of the California Legislature, seeks to amend Section 31522.10 of the Government Code relating to the County Employees Retirement Law of 1937 (CERL). The bill authorizes county boards of retirement to appoint a chief technology officer in addition to the already authorized positions of retirement administrator, chief financial officer, chief operations officer, chief investment officer, and general counsel.

The bill recognizes the evolving needs of retirement systems, particularly the increasing importance of technology in managing retirement benefits and services efficiently. By allowing the appointment of a chief technology officer, SB 1189 aims to enhance the technological capabilities of county retirement systems, ensuring they can better serve their members, including senior citizens who rely on timely and accurate pension benefits.

The County Employees Retirement Law of 1937 provides a framework for counties to establish retirement systems that deliver pension benefits to their employees.
