# Mello-Granlund Older Californians Act

### **Executive Summary**

SB 1249, introduced by Senator Roth during the 2023-2024 Regular Session of the California Legislature, seeks to update and reform the Mello-Granlund Older Californians Act. This act, which outlines the mission of the California Department of Aging, aims to provide leadership and develop systems that allow older adults to remain in their homes or the least restrictive environments. The bill acknowledges the state's demographic shift towards a larger, more diverse senior population and underscores the need to reform the act to better serve this demographic.

The bill highlights the growing complexity of social, medical, cognitive, and behavioral health supports required to meet the needs of an aging population. It emphasizes the importance of policies that promote aging with dignity and independence, aligning with Governor Gavin Newsom's 2019 Executive Order No. N-14-19, which called for the creation of a Master Plan for Aging to prepare for the year 2030 when one in four Californians will be 60 years of age or older.

A significant provision of SB 1249 allows counties the option to petition for designation as their local Area Agency on Aging (AAA). This change aims to enhance local control and improve the responsiveness of AAAs to the specific needs of their communities. The bill mandates the California Department of Aging to develop core programs and services that all AAAs must provide, ensuring a consistent standard of support across the state.

The bill also requires the development of performance measures and a statewide public awareness and engagement strategy. This strategy is designed to raise awareness about available programs and services, improve outreach to underserved populations, and ensure that all older adults can access the support they need. The California Data Dashboard for Aging will be maintained to track demographic changes and help tailor services to the needs of the aging population.

Moreover, SB 1249 authorizes the Department of Aging to enter into necessary contracts for the administration and implementation of the act, promoting flexibility and efficiency in service delivery.

In summary, SB 1249 is a comprehensive reform of the Mello-Granlund Older Californians Act, reflecting California's commitment to its senior citizens. By modernizing the act, the bill aims to ensure that older adults receive the necessary support to age with dignity and independence. This legislative effort is crucial as California prepares for a substantial increase in its senior population, ensuring that older adults remain valued and supported members of the community.
