## **Executive Summary**

AB-1813, introduced by Assembly Member Alanis during the 2023-2024 Regular Session of the California Legislature, establishes the Senior Tenant Shallow Rental Subsidy Program of 2024. This bill mandates the Department of Housing and Community Development to administer a grant program aimed at providing housing subsidies to senior citizens at risk of homelessness.

The bill requires that 50% of the funds be awarded to localities with at least 250,000 residents, while the remaining 50% be awarded to localities with fewer than 250,000 residents. This ensures an equitable distribution of resources across different regions, catering to both urban and rural areas.

The grants will provide rental subsidies of up to \$500 per month for a duration not exceeding 18 months. These subsidies are aimed at senior citizens who meet specific eligibility criteria, including being at least 55 years old, qualifying as low income (at or below 50% of area median income), not receiving other housing subsidies, and either spending at least 50% of their income on rent or being at risk of becoming homeless. Priority will be given to heads of households aged 60 or older and households whose income does not exceed 30% of the area median income.

The Department of Housing and Community Development is authorized to contract with third parties to minimize administrative costs and ensure efficient implementation of the program. Additionally, the department may conduct a multilingual statewide campaign to promote awareness and participation in the program.

Funds awarded through the program must be obligated by July 31, 2025, with provisions for reallocating unspent funds to other eligible grantees.

AB-1813 addresses a critical need among California's senior population, particularly those facing financial hardships and housing instability. By providing rental subsidies, the bill aims to prevent homelessness among seniors, ensuring they can live with dignity and security. The program acknowledges the diverse needs of the senior population, including those of different racial and ethnic backgrounds, and aims to create a more inclusive and supportive community for older adults.

In summary, AB-1813 is a significant legislative effort to support senior citizens in California, providing them with essential housing subsidies and promoting stability and well-being among one of the state's most vulnerable populations.

## **Our Position**

Assembly Bill 1813 (AB-1813) establishes the Senior Tenant Shallow Rental Subsidy Program of 2024, which aims to provide crucial housing support to senior citizens at risk of homelessness in California. This bill directs the Department of Housing and Community Development to administer grants to cities and counties to subsidize the housing costs for eligible senior tenants.

Assembly Bill 1813 (AB-1813) establishes the Senior Tenant Shallow Rental Subsidy Program of 2024, providing rental subsidies of up to \$500 per month for up to 18 months to low-income senior citizens at risk of homelessness. The funds are distributed equally between urban and rural areas. To qualify, seniors must be at least 55 years old, have a low income, not receive other housing subsidies, and either spend at least 50% of their income on rent or be at risk of homelessness. The Department of Housing and Community Development will oversee the program, with a multilingual campaign to promote participation. Funds must be obligated by July 31, 2025, with provisions for reallocating unspent funds. Elderly Care Everywhere strongly supports AB-1813 because it addresses the urgent need for affordable housing among California's growing senior population, alleviating financial burdens and ensuring stable and affordable housing, which is crucial for seniors' health and quality of life. We urge the Assembly Committee on Housing and Community Development to vote in favor of AB-1813 to provide essential financial relief and housing stability for California's senior citizens.
