## **Executive Summary**

AB-1943, introduced by Assembly Member Weber during the 2023-2024 Regular Session of the California Legislature, is an Assembly Bill specifically designed to bolster the integration of telehealth within the Medi-Cal program. This legislative effort mandates the State Department of Health Care Services to meticulously generate a comprehensive public report by October 1, 2025. This report aims to thoroughly examine the utilization of telehealth services among Medi-Cal enrollees, focusing on critical areas such as access and overall usage rates, impacts on the timeliness and quality of healthcare delivery, and the specific effects on clinical outcomes and preventive care measures.

The bill emphasizes a detailed analysis of these facets, including a look at how telehealth affects specialty care. It also requires evaluating how telehealth impacts Healthcare Effectiveness Data and Information Set (HEDIS) quality measures that are reported by Medi-Cal managed care plans. To ensure a thorough understanding of telehealth's impact across various demographics, AB-1943 directs that analyses be stratified by geographic, demographic, and social determinants of health. This stratification aims to identify disparities and ensure that telehealth benefits are equitably distributed among all Medi-Cal enrollees, using existing data approximations such as the Healthy Places Index.

Moreover, the bill grants authority to the Department of Health Care Services, in collaboration with the California Health and Human Services Agency, to formulate and issue policy recommendations based on the insights gleaned from the report. The overarching goal of AB-1943 is to advance state policies that maximize the benefits of telehealth technologies to improve the accessibility and quality of healthcare for all Californians, particularly emphasizing support for the medically underserved communities.

This initiative underscores a significant commitment by the state to not only enhance healthcare delivery through innovative telehealth solutions but also to ensure that these advancements contribute positively to individual patient outcomes and the broader population health. By fostering a more inclusive and efficient healthcare system, AB-1943 aims to set a benchmark in healthcare accessibility and quality, ensuring that all Californians, irrespective of their geographical or socio-economic status, can benefit from the advancements in telehealth technologies.

In summary, AB-1943 is a pivotal legislative measure that seeks to enhance the Medi-Cal program's efficiency and effectiveness through strategic telehealth use. It addresses current needs and sets the stage for future healthcare delivery and policy improvements, ensuring telehealth benefits are realized across California's population. This bill is key in paving the way for a healthier, more accessible, and equitable healthcare system in California.
