### **Executive Summary**

SCR-104, introduced by Senator Nguyen during the 2023-2024 Regular Session of the California Legislature, is a Senate Concurrent Resolution that aims to designate May 2024 as Older Americans Month. This resolution seeks to honor and celebrate the vital contributions of older adults to the state of California. It encourages all Californians to treat older adults with compassion and respect, acknowledging their significant impact on society.

The resolution highlights the role of older adults in fostering inclusivity, diversity, and cultural competency within the state. It also emphasizes the efforts of the California Senior Legislature. This organization has been advocating for the needs of older adults since 1981, focusing on social services, long-term health, and housing and development issues.

SCR-104 underscores the growing senior population in California, noting that thousands of Californians turn 65 years of age each day. It projects an increase in the number of Californians over 60 years old from 7.6 million individuals to 10.8 million by the year 2050. Additionally, it recognizes that women constitute most of California's older population.

It highlights the state's Master Plan on Aging, which aims to create streamlined access to care, develop an appropriately trained and competent workforce, and ensure that older adults can age in their homes with dignity.

By officially recognizing May 2024 as Older Americans Month, SCR-104 aims to raise public awareness about the needs and contributions of older adults. It advocates for increased participation in services and activities that contribute to their health, welfare, and happiness, thereby fostering a more inclusive and supportive community for this growing demographic.
