Executive Summary

Assembly Bill No. 930 (AB 930), introduced by Assembly Member Friedman in the 2023-2024 California Legislature session, amends the Government Code to support the creation of Reinvestment in Infrastructure for a Sustainable and Equitable California (RISE) districts. The bill enables local governments to establish RISE districts jointly, focusing on sustainable development, affordable housing, and equitable infrastructure near public transit.

AB 930 allows legislative bodies of two or more local governments to form a RISE district, which can plan, finance, and implement equitable development projects. The Office of Planning and Research (OPR) must develop guidelines for these districts by November 30, 2026.

The formation process includes setting up a governing board with representatives from each participating government and adopting a development plan that identifies funding sources and implementation tools. This plan requires that at least 50% of funds go to infill supportive infrastructure and 30% to housing for low or moderate-income individuals.

RISE districts can utilize property tax revenues, local sales and use taxes, and transient occupancy taxes. AB 930 also creates a RISE Revolving Loan Fund, managed by the Infrastructure and Economic Development Bank (IBank), to provide initial funding for projects, which may also be financed through tax increment bonds.

Projects financed by RISE districts must comply with specified wage and labor standards, ensuring construction workers are paid prevailing wages. The bill requires an annual independent financial audit and periodic review and amendment of the RISE development plan. Transparency and accountability are emphasized through regular reporting and public hearings.

AB 930 seeks to foster sustainable and equitable development by leveraging joint local government efforts to create vibrant, mixed-use communities. By prioritizing affordable housing and supportive infrastructure in location-efficient areas, the bill aims to reduce disparities, decrease vehicle miles traveled, and enhance community resilience. This legislative effort promotes economic stability and inclusivity, ensuring development benefits extend to historically underserved populations.

In summary, AB 930 addresses California's need for sustainable and equitable development. By facilitating the formation of RISE districts, the bill promotes proactive planning and funding of essential infrastructure and affordable housing. This approach supports the state's goals of reducing greenhouse gas emissions, enhancing community resilience, and promoting economic and social equity.
